- **FHA ACT for ESA**

1. The Fair housing act protects the rights of ESA owners
2. You are allowed to keep your ESA Dog at your place even if the society does not give permission to keep animals
3. You can take your ESA Dog in restaurants and everywhere you go without being discriminated
4. You can travel along your ESA buddy as well

Now you are free to keep your ESA Dog at your place without any hesitation. You can spend quality time with your homie without any restrictions. You just have to get an ESA letter to ensure that your and your [presa canario](#) rights are being protected by the federal law.

### **How can you get an ESA letter?**
